

14 GENERAL BUSINESS

 Security – Now that the school holidays have commenced, there is increased activity around Council buildings especially at night. The Mayor has been out to look at disturbances. Council believe that there is a need for security around our buildings over the Christmas / New Year period and probably for the first 2/3 weeks of January 2022.

CEO asked to look into this matter and see what might be able to be arranged.

- Roaming animals are becoming a bigger problem around the town area. This includes
 dogs, horses and cattle. In the new year, a review of the Local Laws should be
 undertaken with the implementation of a program to assist in addressing this issue.
- Council believes that with the increased awareness around COVID, a protocol should be
 put into place for officials from Government Departments, NGO's etc, to advise Council
 of their proposed visits. This allows a record of who is coming in and out of Hope Vale.
