

c)providing Council with a brief operational and financial report after the event, and

d)liaising with the Senior Community Sports and Recreation Coordinator Hopevale IPDU PCYC in relation to the use of the Matt Bowen MPC and surrounds.

The Association was also advised that Council will donate a further \$500 to the Association upon confirmation that the Matt Bowen MPC and event grounds are left in a neat and tidy condition after the event.

The Association was further advised that Council is agreeable to undertake the requested slashing and grading works and to meet these costs.
