

6.2 CHIEF EXECUTIVE OFFICER'S REPORT

6.2.1 Mayors Working Group - \$40 Million Remote Housing Program

At a recent meeting of the Group, it was decided that the views of each indigenous local government would be sought on their preferred distribution of the \$40 million Remote Housing Package. The two main options for distribution were

- On a per capita basis
- Equally divided amongst each indigenous local government

6.2.2 Reef Councils Major Integrated Projects Proposal

In November 2018 the LGAQ had contacted Council regarding our support in endorsing the "Reef Councils Major Integrated Projects". They followed up with their request on 31st January 2018 and they were advised that Council was happy of endorse the proposal.

6.2.3 Apunipima

Apunipima CEO Paul Stephenson emailed through a recent Apunipima Hope Vale Community Health Data Report that was on the back of Council's request for information and clarification around their services. Apunipima CEO Paul Stephenson acknowledged that Council would like more regular information on health measures and health status data within Hope Vale and he is proposing to provide this document bi-annually.

6.2.4 Cooktown 2020 Festival Consortium

Mayor Peter Scott has invited Hope Vale Council to join the Cooktown 2020 Festival consortium. The proposed consortium members would be:

The Festival is expected to take place between 17th June through to 4th August 2020 and its key theme is "Our Shared History". Council has emailed back an acceptance letter to Cook Shire's invitation to join the consortium.

6.2.5 Economic Development Strategy

Tracey Wilson and Director Finance Shannon Gibbs have completed the Economic Development Strategy Approach Document which has been called 'Hopevale 2023". The idea around the document is to outline how Council can deliver the strategy. It is still currently in draft form so that Council can review it. The Director of Finance and Tracey Wilson also met with V & V International. They emailed Council after the meeting and want to have further talks on how they can contribute to the growth of Hope Vale. They indicated that they foresee the following:

Contributing to our open field cropping

Potentially developing a small enclosed Container Horticultural facility

It was agreed that Council invite representatives of V&V International to Hope Vale to meet with Council.





6.2.6 Island and Cape Supermarket Closure

A briefing was provided to Council on the temporary closure of the Hope Vale Supermarket in January 2019.

It was agreed that

- (a) Council note the circumstances and actions concerning the temporary closure of the Hope Vale Supermarket,
- (b) the CEO investigate maintenance standards at Everlina Plaza, and
- (c) the CEO undertake discussions with Island and Cape concerning ongoing leasing arrangements and issues with the dispensing of fuel at the service station.

6.2.7 Department of Local Government Training

Council was advised that there was sponsorship available for a range of training programs to assist Council's elected members and officers. All Councils were invited to nominate their interest for these programs. The training available is:

6.2.9 Get Playing Places and Spaces Grant Funding Announcement

Council was advised in December 2018 of a successful grant application for \$109,271. This grant is for Council to install a new playground, outdoor fitness stations and a half court basketball court at the MPC.

6.2.11 Local Government Grants & Subsidy Program

The 2019–21 Local Government Grants and Subsidies Program (LGGSP) is a competitive grant program available to all Queensland Local Governments. The primary aim of this program is to provide funding assistance to support Local Governments to deliver priority infrastructure and essential services that meet the identified needs of communities.

Council has applied for the following projects inside the 2019 - 2021 LGGSP funding round -

Banana Farm Road - Resilience project

The two coat sealing of the full length, 2064m gravel surfaced Banana Farm Road, to increase flood immunity and provide increased resilience to high velocity flood waters associated with severe weather events. The current gravel road is vulnerable to scouring, loss of material and inundation and has sustained repeated significant damage as a result of multiple natural disasters.

Value - \$314,329.70

Elim Road – Resilience Project

The two coats sealing of the full length, the remaining 20,000m gravel surfaced Elim Road, to increase flood immunity and provide increased resilience to high velocity flood waters associated with severe weather events. The current gravel road is vulnerable to scouring, loss of material and inundation and has sustained repeated significant damage as a result of multiple natural disasters

Value - \$2,889,582.00

It was agreed that Council note the submission of the following applications pursuant to the 2019–21 Local Government Grants and Subsidies Program -

- •Banana Farm Road Resilience project \$314,329.70
- •Elim Road Resilience Project \$2,889,582.00





6.2.12 Disaster Recovery Funding Arrangements - North and Far North Queensland Monsoon Trough, 25 January – 6 February 2019 Event.

The Disaster Recovery Funding Arrangements (DRFA) assistance measures of Counter Disaster Operations (CDO) and Restoration of Essential Public Assets (REPA) were activated January 31st under the Queensland Reconstruction Authority.

Council has organised for the damage to be assessed through our project management. This assessment began on Monday 11th February and will continue for the full week. Once the damage assessment is complete, Council will populate the scoping document for the Queensland Reconstruction Authority to approve and works to repair the damage will be schedules in once approved.

It was agreed that Council note the activation of the Disaster Recovery Funding Arrangements (DRFA) assistance measures of Counter Disaster Operations (CDO) and Restoration of Essential Public Assets (REPA) under the Queensland Reconstruction Authority.
