

6.1.1 Schooling and Educational Services - Hope Vale

On 25 August 2022, Council wrote to the Department of Education, expressing concern about some matters relating to the provision of schooling and educational services within Hope Vale. A few of these issues included:

- An increasing number of disengaged young children within Hope Vale that do not attend school or have no desire to attend school,
- A reducing rate of Hope Vale's youth that manage to complete their schooling,
- Feedback from community members and parents that the school children are not engaged at school or by the curriculum,
- Feedback from parents that their children struggle with transition to secondary schooling because of an apparent lower level of academic knowledge, and
- Feedback from community members that the Hope Vale Campus, including buildings and grounds, is not inviting or conducive to school attendance.

The Department was advised that the education of our youth is a critical issue for Hope Vale, but it is difficult for Council to have a position in relation to this matter, without good qualitative and quantitative data and an independent assessment.

Accordingly, the Department was requested to commission an independent review of schooling and educational services within Hope Vale. It was considered that the review should incorporate all facets of our children's education, including Council's Child Care and Kindy, the Playgroup, and the Hope Vale Campus. Council wants to be satisfied that the children of Hope Vale are provided with the best possible foundation for their future.

By letter dated 27 October 2022, the Department of Education advised -

"The Department of Education greatly values community input and engagement with educational services and we look forward to working with you into the future.

At this point, the Department of Education has endorsed a renewal of the Partnership Agreement with Good to Great Schools Australia for a period of three years, concluding in December 2025.

The Department remains committed to ongoing improvement and the continual evaluation of educational services delivered in State schools. As such, schools are reviewed by a team of trained reviewers every four years.

The Cape York Aboriginal Australian Academy is scheduled to undergo a full school review in early 2023. As part of this process the review team will contact a range of stakeholders to invite feedback and insight into the delivery of educational services at both Hope Vale and Coen campuses. We will ensure that the Hope Vale Council is consulted during this process. Further details regarding the timing of this review will be forwarded as soon as possible."

It appears that the Education Department has missed the point of Councils request for holistic, independent review of schooling and educational services within Hope Vale, incorporating all facets of Hope Vale's children's education. The Department's response focuses only on the Hope Vale Campus and its intention to renew the Partnership Agreement with Good to Great Schools Australia for a period of three years, concluding in December 2025.
