HOPE VALE DG CHAMPION VISIT

ESTABLISHMENT OF PCYC

QPS State Coordinator inquiries into the establishment of a PCYC in Hope Vale have reviewed the QPCYWA proposal was based on the more recent model rolled out in Woorabinda. CEO to follow up with alternative options.

HOUSING INSPECTIONS - HPW

The ATSI Housing Unit will recommence property inspections on their leased housing stock in Hope Vale. The purpose of the inspections is to record the condition of the dwellings and ensure they are safe and functional. This will assist Housing identify works for future programs and satisfies their legal obligation as the housing provider.
