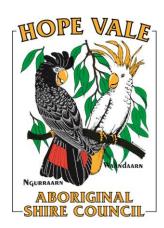

## Item 3: Interim Hope Vale Local Thriving Communities Advisory Committee Report

## **Item 4: Hope Vale Events Coordination Advisory Committee Proposal**

At its meeting held on 15 February 2023, Council resolved that it "support "in principle" the formation of a Hope Vale Events Co-ordination Advisory Committee and a further report be submitted in relation to the proposal"

At its meeting held on 15 March 2023 Council considered a draft Terms of Reference for a proposed Hope Vale Events Coordination Advisory Committee. The draft Terms of Reference are based on the Interim Hope Vale Local Thriving Communities Advisory Committee Terms of Reference.

At this meeting, Council resolved to defer consideration of a Hope Vale Events Coordination Advisory Committee proposal to its next meeting.

## **Recommendation:**

That Council consider the formation of a Hope Vale Events Coordination Advisory Committee.

## **Item 5: Governance Framework**

Governance is an important concept and impacts on Council as a whole and on all sectors of the community. The practice of good governance is increasingly seen as critical for ensuring that:

- the organisation meets legal and ethical compliance
- decisions are made in the interests of stakeholders
- the organisation behaves as a good corporate citizen should.

Good governance encompasses authority, accountability, stewardship, leadership, direction and control. The role of leadership is to embed an ethical culture from the top down. It allows Council to evaluate, direct and monitor its activities. Good governance generally focuses on

two main requirements:

- performance, whereby the organisation uses its governance arrangements to contribute to its overall performance and the delivery of its goods, services or programs.
- conformance, whereby the organisation uses its governance arrangements to ensure it meets the requirements of the law, regulations, published standards and community expectations of probity, accountability, and openness.

Without good governance processes, Council can have little confidence that the organisation is being run efficiently and is carrying out the Council's objectives, policies, and supporting documents.

Accordingly, Council's existing Governance Framework has been documented and submitted for Council's consideration. (Attachment C)

#### Recommendation

That Council endorse the Hope Vale Aboriginal Shire Council Governance Framework attached to the Chief Executive Officer's report

# **Item 6: Organisational Structure**

Section 196 (1) of the Local Government Act 2009 states –

(1) A local government must, by resolution, adopt an organisational structure that is appropriate to the performance of the local government's responsibilities.

Council is aware that an extensive review is being undertaken on the Council's Human Resources role on how Council deliver this important function for the organisation. All Human Resource's policies, documentation, systems, and processes are being reviewed

At its meeting held on 18 January 2023, Council considered the existing organizational structure (Attachment D) and resolved –

"That Council defer reconfirming the current Council organizational structure until a future meeting."

It is requested that Council reconsider this issue
