

COUNCIL REPORT Meeting 26 July 2023



Item 1: Meetings Attended

- Mayor and CEO met with Sumant P Narula, Chief Financial Officer and representatives from Cape Flattery Silica Mines Pty Ltd in Hope Vale on 20 June 2023 in relation a proposed funding arrangement for the pool.

Item 2: Torres Cape Indigenous Council Alliance (TCICA) Inc - July 2023 Meeting

The Torres Cape Indigenous Council Alliance (TCICA) Inc met in Cairns on 4 and 5 July 2023. The meeting was attended by the CEO. The attached Meeting Communiqué (Attachment A) on the meeting is attached for Council information.

Item 3: Torres and Cape Health Care Commissioning Fund (TORCH)

Queensland Health have advised that it is committed to exploring whether bringing funding decisions closer to community under the establishment of a Torres and Cape Health Care

Commissioning Fund (TORCH) will help reform the current state of heath care in the Torres and Cape regions.

Representatives from the TORCH project has addressed TCICA on various occasions since April 2021 and have advised that -

TORCH is to be a whole of population approach to health care, but with more than 70% of the population identifying as First Nations' peoples a place-based approach will require First Nation leadership

The project is aligned to the Hospital and Health Service boundaries which incorporates the LGAs of Aurukun, Cook, Hope Vale, Kowanyama, Lockhart River, Mapoon, Napranum Northern Peninsula Area, Pormpuraaw Torres Shire, Torres Strait, Weipa, and Wujal Wujal

TORCH seeks to maximise existing investment and to innovate the way in which health care services are funded, contracted and provided The ambition is to establish an independent entity responsible for commissioning health services across the region.

It will also provide an increased opportunity for communities in the region to influence decision making and investment decisions in health through improved shared partnerships and effective service delivery.

It is now proposed that TCICA Mayors sign a Statement of Intent to establish a Torres and Cape Health Care (TORCH) commissioning entity.

Recommendation:

That Council consider if it supports a proposed Statement of Intent to establish a Torres and Cape Health Care (TORCH) commissioning entity.

Item 4: 2023 LGAQ Conference Motions

The motions 2023 LGAQ Conference have been opened. Motions that have been passed as resolutions by councils are therefore requested to be submitted no later than Wednesday 9 August 2023. This will enable the LGAQ Agenda Committee to review all submitted motions and provide a Preliminary Agenda for member councils four (4) weeks prior to the commencement of Conference.

At both the recent Indigenous Leaders Forum and TCICA meeting, it was agreed that Hope Vale Aboriginal Shire Council would move the following motion –

That the LGAQ requests the State and Federal governments to

- investigate health service delivery to ensure appropriate integration with complementary services in First Nations communities including community-controlled health services
- alter the roll out of "home dialysis" programs to include a more expansive "community dialysis" approach to allow dialysis to take place in community in a safe environment more appropriate to a First Nations context.
- consider community-led palliative care models to ensure First Nations peoples have their right to heal and seek end-of-life support on country.

Recommendation:

That Council endorse the following motion for consideration at the 2023 LGAQ Conference – That the LGAQ requests the State and Federal governments to

- investigate health service delivery to ensure appropriate integration with complementary services in First Nations communities including community controlled health services
- alter the roll out of "home dialysis" programs to include a more expansive "community dialysis" approach to allow dialysis to take place in community in a safe environment more appropriate to a First Nations context.
- consider community-led palliative care models to ensure First Nations peoples have their right to heal and seek end-of-life support on country.
